

2020 Orton-Gillingham Approach Teacher/Tutor Training for Dyslexia and Literacy Instruction

Instructor: Nancy Redding, Fellow/Academy of Orton-Gillingham Practitioners and Educators **Location**: Los Altos Christian School, 625 Magdalena Ave., Los Altos, CA 94024 **Registration Closes June 7th**. Class will close once full.

Coursework needed to achieve the <u>Classroom Educator</u> certification will be taught in a 40 hour course from June 15 - 19; registrant should be currently employed by a public or private school. This level of membership prepares a teacher for implementing the Orton Gillingham Approach within a classroom or group, but not one-on-one tutoring.

The Associate level coursework of the Academy of Orton-Gillingham Practitioners and Educators (AOGPE) will be taught in two sessions: the 5 day training from June 15 – June 19 followed by a 3 day training July 6-8 at LACS. Completion of the Associate level prepares individuals to teach one-on-one, and with any size group.

Classroom Educator coursework covers the following topics (40 hours). Associate coursework covers these topics (first 40 hours) plus additional topics, as noted (61 hours).

- Classroom Educator: June 15-19, 2020 (Monday Friday 8:30 5:00) \$725
 - Dyslexia and reading disorders
 - The rationale for structured literacy, in particular the Orton-Gillingham Approach
 - o Phonology & phonological awareness
 - o The motor component, orthography of English, and the writing process
 - Basic phonics for reading and spelling
 - o Intermediate phonics for reading and spelling
 - o The lesson plan, and teaching materials
 - o General history of the English language and beginning morphology
 - Informal assessment and diagnostic-prescriptive teaching
 - Accuracy, automaticity, and fluency
- Additional topics for Associate Level: July 6-8, 2019 (Mon–Wed 8:30 4:30) \$250 (dates are still tentative)
 - Vocabulary development and basic grammar
 - Interpreting formal assessments
 - o Emotional implications of dyslexia and related learning disabilities
 - o The place of AT in remediation of dyslexia
 - o Elements of reading comprehension

- Providing direct one-on-one instruction
- o The Academy's philosophy, standards, and certification requirements

The total cost of Classroom Educator coursework is \$725; total cost for Associate coursework is \$975. Space is limited. Course fee includes the courses' training manual, Student Notebook, and 4 decks of drill cards. Participants must provide some supplies and their own lunch/snacks. A list of required readings and supplies is provided upon request or registration.
