



## Orton Gillingham Teacher/Tutor Training for Dyslexia and Literacy Instruction

Classwork for **Classroom Educator** level certification will be taught in a 40 hour course from June 10 – 14, 2023. 35 hours will be in-person, with 5 hours of independent work. Registrants should currently be employed by a public or private school if certification at CE level is desired. This level of membership prepares a teacher for implementing the OG Approach within a classroom or small group.

The **Associates Level** coursework for certification will be taught in 2 sessions: June 10-14 at ACDS and online Aug. 24 & 25, Sept. 7 & 8, 2024. For the second part of Associates Training, 20 hours will be live on Zoom, with 5 hours of independent work. Completion of the Associate level prepares individuals to teach 1:1, or with any size group.

  - Interpreting formal assessments
  - Elements of reading comprehension & Written Expression
  - Providing one-to-one instruction

The cost for the OGCE coursework is \$1,000; total cost for the Associates level is \$1,000 + \$500. Space is limited. Course fee includes the printed training manual, phonics book and 3 decks of drill cards. A list of recommended reading and supplies is provided upon request or registration.
